V-PL1 - The School-Based Occupational Therapy Practitioner within a Multi-Tiered Support System: Teacher Perceptions of Coaching and Classroom-Centered Intervention in Early Elementary Education

Course Description: This study explores how the School-Based Occupational Therapy Practitioner (SBOTP) can reach a larger population of students and prevent children from needing more individualized support through the promotion of inclusive Tier 1 support. Using a collective case-study approach, this study examines teachers' perceptions of classroom-centered barriers, priorities, and the impact of a coaching approach on occupational participation.

Course Description: Implantable vagus nerve stimulation (VNS) paired with upper extremity rehabilitation with the Vivistim Paired VNS system is an FDA approved therapy for moderate to severe chronic ischemic stroke. This session will discuss the preliminary findings of a real-world implementation study of Paired VNS provided exclusively in the home setting by mobile therapists. The potential benefits and challenges of in-home Paired VNS will be discussed.

Course Description: Youth in the lesbian, gay, bisexual, transgender, queer/questioning, and other dissident genders and sexualities (LGBTQ+) community face extensive health inequities and dynamic political landscapes. Occupational therapy (OT) has potential to support LGBTQ+ youth, however, there is limited guidance for practitioners seeking to implement evidence-based interventions with this group. This presentation will outline select interventions within the scope of OT based on results of a scoping review.

Presenters will provide an overview of a hospital system program addressing the needs of children and adults with intellectual and developmental disabilities during hospital stays. A case study demonstrating the effectiveness of the implementation of the program for an adult patient will be provided.

Course Description: CP is the most common childhood physical disability, with one-third of children affected unilaterally. Evidence-based interventions such as modified constraint-induced movement therapy, bimanual intensive training, and goal-directed training support functional gains, though optimal dosage varies. We will highlight the evolution of an intensive OT program focused on improving UE function in children with unilateral CP, incorporates evidence-based strategies into dynamic, group-based formats.
