# Advocacy

#### **Summary of Advocacy Efforts and Issues:**

- The Director of Advocacy has engaged in ongoing communication with ILOTA Lobbyist & ILOTPAC related to legislative/advocacy issues including telehealth and OT compact.
- Initiated use of the Advocacy Advisory Group to connect with experts in various practice areas for support around legislative/advocacy issues.
- Director of Advocacy maintained a seat on the ILOTPAC executive board
- Collaborated with ILOTA Lobbyist to create a document to organize general assembly bills impacting OT practices. Created "Need to Know" General Assembly timeline and information related to advocacy issues.

#### Outreach:

- Attended campaign fundraiser for Meg Cappel
- Presented to a local university OT program about advocacy
- Worked with Public Policy Coordinator to send out letters to OTs in legislative areas seeking volunteers to lead advocacy in their areas.

#### Telehealth:

- Supported various advocacy actions to support telehealth including sending out requests for witness slips, sending letters to ILOTA members encouraging them to contact their legislators, and providing templates for seeking legislative support.
- Sent letters of appreciation to supporters of the Telehealth Bill once passed

#### **School-based Practice:**

- Supported an OT doctoral capstone student project on school-based advocacy
- Held town halls around advocating for educational licensure for school OTs
- Joined the AOTA State Leaders in School Practice Community of Practice to advocate for school OTs
- Represented ILOTA in the AOTA Path to School Leadership Roundtable
- Supported school SIS Co-Chair participation in "Back to School" event hosted by State Representative Dag Avelar at Irene King School in Romeoville inpartnership with ILOTPAC and Midwestern OTD students.
